# Notice Regarding Establishment of Joint Venture and Changes in Specified Subsidiaries

Nitta Gelatin Inc. has announced that at a Board of Directors' meeting held on June 27, 2012 the Company passed a resolution to increase capital in Nitta Casings Inc., a consolidated subsidiary. Nitta Casings Inc. will in turn invest in Beijing Nitta Collagen Casing Co., Ltd. (provisional name), a Chinese joint venture. Today's announcement relates to a press release titled "Notice Regarding Joint Venture in China" dated March 21, 2012.

Beijing Nitta Collagen Casing Co., Ltd. (provisional name) and Nitta Hong Kong Ltd. will also become specified subsidiaries of Nitta Gelatin Inc.

### 1. Purpose of Establishment

The Nitta Gelatin Group has long been engaged in the collagen casing business. To further expand this business in China, we will establish a joint venture company.

#### 2. Method of Establishment

Plans call for Nitta Casings Inc. (consolidated subsidiary) to increase capital in Hong Kong-based company Nitta Hong Kong Ltd. (consolidated subsidiary), which will establish the joint venture following approval of the application for establishment to the Beijing City government.
